To obtain a replacement Tennessee motor vehicle title, lienholder(s) or owners(s) (e.g., military personnel or former Hamilton County residents), please complete the bold outlined areas of this application. Application requires the owner(s), or appointed power of attorney, to sign their name in the box designated "SIGNATURE OF CERTIFIER/OWNER or POWER OF ATTORNEY". Lienholder(s) will need to sign and print the name of the lienholder(s) and sign their name as the individual representative(s).
- 2. Person(s) making application submit copy of driver license(s).
- 3. Lienholder(s) must make payment by check drawn on their financial institution's account; all others submit a cashier's check or money order in the amount of \$14.00.
